Special Conditions

Small Society Lotteries – proceeds and other monetary limits:

- A Small Society Lottery must apply a minimum of 20% of the gross proceeds of each lottery directly to the purposes of the Society.
- Up to a maximum of 80% of the gross proceeds of each lottery may be divided between prizes and the expenses of the lottery.
- The maximum prize in a single lottery is £25,000.
- Up to £20,000 worth of tickets may be sold and the Society's aggregate proceeds from lotteries must not exceed £250,000 a year.
- Rollovers are permitted provided the maximum single prize limit is not breached.
- Every ticket in the lottery must be the same price and the cost of purchased tickets must be paid to the Society before entry into the draw is allowed.
- There is no maximum price for a lottery ticket.

Ticket Information:

- All tickets in a Society lottery must be licenced by either the Gambling Commission (ie Large SocietyLotteries) or Registered with a Licensing Authority (Small Society Lotteries) and must state:
 - Name of the Society on whose behalf the lottery is being promoted.
 - Price of the ticket.
 - Name and address of the member of the Society responsible for the promotion of the lottery (in the case of a Small Society Lottery run under the Licensing Authority registration, the name and address of the External Lottery Manager, if there is one, may be given as an alternative).
 - o Date of the draw, or the mean by which the date may be determined
 - The fact, where that is the case, that the Society is licensed by the Gambling Commission.

Tickets which are issued through a remote form of communication or any other electronic manner must specify this information to the purchase of the ticket and ensure that the message can be either retained or printed.

Once the contestant has successfully entered the contest an invoice stating the quantity of tickets purchased, the total cost of the tickets purchased and a copy of the terms and conditions will be emailed to the contestant.

Raffle Draw Information:

- The contestant will not be issued raffle ticket numbers.
- Tickets will be onsale until 6pm, 17th of December, 2021.
- The draw date will be 8:00pm, 17th of December, 2021.
- Winners will be announced via club social media.
- Winners will be contacted immediately after the draw to be notified to claim their prize/s. The winners have up to 7 days from notification to claim their prize/s. The organisers best efforts will be made to contact the winners via contact details registered upon draw entry.
- If a prize is unclaimed, a winner will redrawn from the remaining valid entries.
- All prizes cannot be transferred or redeemed for cash value.
- On the draw date a list of tickets sold will be collated. Ticket numbers will be allocated based on the earliest invoice first, then split into ticket quantity.
 - For Example: Invoice 001 1 ticket, Invoice 002 5 tickets, Invoice 003 2 tickets.

- Once the ticket numbers have been collated a random number generator will be used to pick a random number between 1 and the total number of tickets sold.

 - Date on which the tickets were available for sale or supply and the date of the draw.
 - Total proceeds of the lottery.
 - Amounts deducted by promoters of the lottery in providing prizes, including rollovers.
 - Amounts deducted by the promoters of the lottery in respect of costs incurred in organising the lottery.
 - The amount applied directly to the purpose for which the promoting society is conducted.
 - Whether any expenses incurred in connection with the lottery were not paid for by deduction from the proceeds, and (if so) the amount of expenses and the sources from which they were paid.

A registered Society's statement must be sent to the Licensing Authority within three months, beginning on the day on which the draw (or last draw) in the lottery took place. It must be signed by two members of the Society appointed in writing for that purpose by the Society's governing body and accompanied by a copy of that appointment.

Age for participating in a Lottery:

The minimum age for participation in a lottery is 16 years of age.

Data Protection:

By purchasing a ticket, the entrant agrees to Manchester Baseball Club collecting personal and private contact information for the purposes of the raffle. All private and personal data will be deleted within 90 days of the raffle draw date.

Other Information:
